#### AQUATICS SECTION REPORT

- A new Bill is being proposed that would require DWD to permit minors 15 years of age or older to be employed as lifeguards. Even though 15 year olds are trained through the American Red Cross that is only the beginning of their training. Safety and success requires excellent site specific training, ongoing skill work, partnering youth staff with veteran staff and having knowledgeable pool managers. We are putting our youth in a Professional Position at a very young age. The Aquatics Committee suggestion was more training opportunities provided in school and funding to help support certification classes.
- Aquatic Technicians Workshops were held on April 6 (Eau Claire) and April 21 (Jefferson). Registration was lower than expected. The Aquatics section will not run the technician workshop in conjunction with the WPRA Joint Workshop in 2018.
- Aquatic Seminar is scheduled for Friday, May 19<sup>th</sup> in Oconomowoc. Register online deadline is May 5 \$28.00 for WPRA members and \$38.00 for non-WPRA members, and then a \$5 late fee will be instituted. Topics include: Lifeguarding: how do we want the public to perceive us, respected as a Supervisor not as an equal, Dealing with Hostile Situations
